9. Old Business

- a. 2024 budget draft
 - i. The figures: **2023-** Income \$272,567, expenses \$272,219, **surplus \$348. 2024-**income \$256,036, expenses \$281,850, **deficit \$25,814.**
 - ii. Some reasons for change:
 - a. 2020 census under reported people
 - b. Municipality funding is weak. \$1. Is necessary for matching funds and all municipalities comply. Good funding would be \$5. Per person.
 - c. Unfunded mandates for computers and healthcare.
 - d. Formula for matching funds from the County has changed. If other public libraries are 10 miles or more away, you get distance support. We are not.
 - e. PR issues: a. books are cheaper than e books that have limited use & are more expensive. b. If you use "Libby" it is free for you, but the library pays the cost. So you should support the library for this service.
 - f. Budget discussion: We explored ideas for increasing our income and reducing our expenses. A discussion of personnel was had with the expectation that changes would occur during 2024.
